Please write your email clearly, entries will be acknowledged by email only.

Inspection: Check in and inspection will be done at the same time. Each entry will be inspected by the inspection committee for lameness, fitness to compete and females in season. All dogs to be inspected must be presented WITHOUT TAPE, BANDAGES or WRAPPING, COVERING of any kind. (coats, blankets, etc) If, in the opinion of the inspection committee, any entry is found to

be lame, unfit to compete or in season. They shall not be allowed to test, and the applicable entry fees shall be refunded.

Practice Runs: Practice will be held when no test participants are waiting. \$5.00 per practice run.

Running Your Dog: It is recommended that dogs be handled with a "slip-lead" that gives an instantaneous freedom to the dog when "Tallyho" (release) signal is called by the Huntmaster.

Dogs may run with or without any collar for safety reasons. Unacceptable collars are choker collar, a collar with prongs or an electric training collar.

Owners may use a rubber band to hold the dog's hair from their eyes. The owner assumes responsibility for the safety of the dog with regard to the dog's collar and paraphernalia on the dog.

Refund Policy: NO refunds after closing date will be given for any reason. Refunds are allowed prior to closing date with the exception of refunds less than \$10. These will not be processed at any time.

Eligibility Open to all dogs at least 12 months of age that are individually registered with AKC, recorded in the Foundation Stock Services (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. Females in season may not enter. A dog may enter only once per event number.
