I, and any guest(s) I may bring, **HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING IN THIS ACTIVITY OR EVENT**, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault. This Release shall extend to any and all claims for damage to persons or property of any types whatsoever caused by my dog, myself and/or my invitees while on the training area used by MADTA, any property adjacent thereto and any other venue where I participate in activities sponsored by MADTA.

I certify that I am physically fit, to participate in the activity or event that I have not been advised to not participate by a qualified medical professional and that there are no health-related reasons or conditions which preclude my participation in this activity or event.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of MADTA and/or the activity or event in which I may participate, and that it will govern my actions and responsibilities at said activity or event.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:
