Pursuant to UKC rules, dogs may enter both Agility I and Agility II, but the U-AGII title will not be awarded until the requirements for U-AGI are completed. Dogs must already have the U-ACH title to enter Agility III

AG-I and AG-II are divided, 'A' classes are for dogs that have not earned a title at that level. U-ACH points are only earned from the 'B' classes. Please include your dog's UKC agility titles as part of your dog's name on the entry form. This will assist the Trial Secretary in assuring that you are entered in the correct class.

Height Divisions

Owners are responsible for entering the proper height divisions. The judge reserves the right to measure dogs enter in the trial.

- Dogs up to 10 inches.....Toy Division (4" hurdle and Hoop)
- Dogs over 10 inches up to 14 inches. Division 1 (8" Hurdle and Hoop)
- Dogs over 14 inches up to 20 inches.... Division 2 (14" Hurdle and Hoop)
- Dogs over 20 inchesDivision 3 (20" Hurdle and Hoop)

BE SURE TO NOTE YOUR DOG'S HEIGHT ON YOUR ENTRY FORM.
BE SURE TO INDICATE IF YOUR DOG IS RUNNING VETERAN JUMPS.

REQUIREMENTS/REQUESTS THAT YOU CAN EXPECT AT THE TRIAL/EVENT.

1. Limited **INDOOR CRATING** for participants.
2. Exhibitors should be present prior to start of their class and must report to the ring steward table upon arrival to check in. If you have a conflict with multiple ring entry times, notify the table stewards and they will see if accommodations can be made by the Judge.
3. Exhibitors must have their dogs use the designated exercise area outside the trial facility. Please clean up after your dog. Should your dog have an accident inside the facility please ask for cleaning supplies.
4. Three (3) dogs and handlers will be allowed by the ring area at one time (the dog working in the ring and the next two (2) on deck).
5. Food will NOT be available onsite. Please plan on bringing our own lunch, water, drinks, and water for dogs, etc.
6. Parking: Handicapped Parking with proper tags only will be allowed to park by the building.
7. All participants are expected to follow facility guidelines
8. Please do not park in front of any Gates going behind the building. As there will be parking available behind the building.

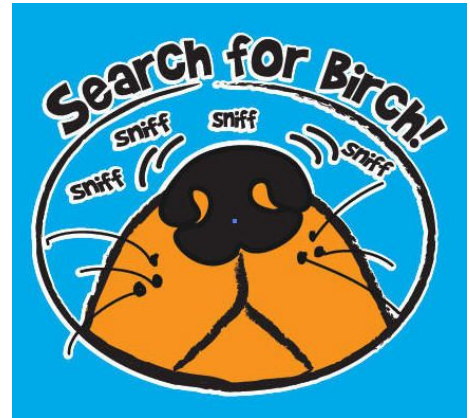
