Please write your email clearly, entries will be acknowledged by email only.

<u>Inspection:</u> Check in and inspection will be done at the same time. Each entry will be inspected by the inspection committee for lameness, fitness to compete and females in season. All dogs to be inspected must be presented WITHOUT TAPE, BANDAGES or WRAPPING, COVERING of any

kind. (coats, blankets, etc) If, in the opinion of the inspection committee, any entry is found to

be lame, unfit to compete or in season, they shall not be allowed to test and the applicable entry fees shall be refunded.

Practice Runs: Practice will be held when no test participants are waiting. \$8.00 per practice run.

Running Your Dog: It is recommended that dogs be handled with a "slip-lead" that gives an instantaneous freedom to the dog when "Tallyho" (release) signal is called by the Huntmaster.

Dogs may run with or without any collar for safety reasons. Unacceptable collars are choker collar, a prongs collar or an electric training collar.

Owners may use a rubber band to hold the dog's hair from their eyes. The owner assumes responsibility for the safety of the dog with regard to the dog's collar and paraphernalia on the dog.

Refund Policy: NO refunds after closing date will be given for any reason. Refunds are allowed prior to closing date less a \$10.00 fee. No exceptions.

<u>Eligibility</u> Open to all dogs at least 12 months of age that are individually registered with AKC, recorded in the Foundation Stock Services (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. Females in season may not enter. A dog may enter only once per event number.

CONDITIONS OF ENTRY

- All entries must be one year of age or older on the day of the test.
- Bitches in season and lame dogs will be excused. Entries will be refunded.
- No flexi leashes.
- ~ A \$5.00 fine will be assessed for any loose dog on the field that is not competing on the course in progress.
- Once your dog enters the field there will be no refunds, even if your dog does not want to run.
- ~ A \$5.00 fine will be assessed for any handler not cleaning up after their dog.
- No human aggressive dogs allowed. Any dog displaying aggression towards people will be asked to leave without refund.
- Battery or gas powered, continuous loop equipment will be used.
- ~ Lure consists of white plastic.
- MADTA reserves the right to alter course due to field and/or weather conditions on the day of the test.
- At its discretion, MADTA may break periodically during the day to accommodate judge and worker ring times and lunch.

- ~ PINCH collars are prohibited on the event site.
- ~ Children MUST be under control of their parents or guardians at all times.
- Only the Lure Operator, Huntmaster, Judge and Handler of the dog running in the course in progress will be permitted near the lure machine.
